Background:

Some products have literally doubled in price or have become unable to obtain since I purchased Flowers-n-More. As my costs increase, I must pass that on to the customer and there is fear the escalations may drive customers to purchase from large supply chains or big box stores where the prices may be lower (but so is the quality and care that goes into them). I want my customers to know we are giving the best price we can, and by keeping their purchases local, it supports Albany as a whole!




Congratulations to This Year's Leadership Albany Participants!
